#### **Prerequisites for Licensing (Please consult the ADGA Guidebook):**

- You must be 18 or older by the special training conference date.
- You must have a current, individual ADGA membership with your dues paid.
- You must have completed a Pre-TC in the past 24 months or complete the Pre-TC on June 4th.
- You must pay the \$25.00 license fee to ADGA.

Auditors participate in all parts of the training conference, but are not candidates and are not eligible for a Judge's License. If you choose register as an Auditor, you will not be eligible to qualify for a Judge's License even if you pass all parts of the TC.
